

THE WORSHIP INITIATIVE, LLC "2026 LEADING THROUGH ADVENT WEBINAR GIVEAWAY" — Official Rules

NO PURCHASE, SUBSCRIPTION, OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER THE SWEEPSTAKES OR WIN. A PURCHASE, TRIAL SUBSCRIPTION, OR PAID SUBSCRIPTION DOES NOT AND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE THE UNITED STATES, IN PUERTO RICO, AND WHERE PROHIBITED BY LAW.

DETAILS OF THE PRIZE AND HOW TO ENTER THE SWEEPSTAKES ARE CONTAINED IN THESE OFFICIAL RULES.

Eligibility

The "2026 Leading Through Advent Webinar Giveaway" (the "**Sweepstakes**") is open only to legal residents of the 50 United States and the District of Columbia (excluding residents of Rhode Island, Florida, New York, California, and any state where this Sweepstakes is prohibited by law), who are at least eighteen (18) years old at the time of entry. Void where prohibited. The following are not eligible for the Sweepstakes: employees, officers, and directors of any company or individual involved with the design, production, execution, or distribution of the Sweepstakes, and their immediate family members (meaning spouses, parents, siblings, and children living in the same household). Proof of legal United States residency, age, and eligibility verification may be required.

Sweepstakes Period

The Sweepstakes begins at 12:00 a.m. CST on September 29, 2026 and officially ends at 11:59 p.m. CST on September 29, 2026 (the "**Entry Period**").

Sponsor

How to Enter the Sweepstakes

Method One — Webinar Auto-Entry: Participants who (1) register for the webinar at <https://secure.worshipinitiative.com/leading-through-advent-2026> and (2) attend the webinar will be automatically entered into the Sweepstakes. No separate action is required to enter via this method.

If you register for the webinar but do not wish to be entered into the Sweepstakes, please send an email with your name, home address, and the phone number associated with your account asking to be removed to marketing@worshipinitiative.com, and you will not be entered into this Sweepstakes.

Method Two — Free Alternate Method of Entry (AMOE): To enter without registering and attending the webinar, send an email to marketing@worshipinitiative.com with the subject line "2026 Leading Through Advent Webinar Giveaway" and include your full name, complete mailing address, daytime phone number, email address, and date of birth in the body of the email. Email entries must be received by 11:59 p.m. CST on September 29, 2026. AMOE entries have the same odds of winning as entries received through Method One.

Regardless of method of entry, all entrants ("**Entrants**") are subject to verification of eligibility and compliance with these Official Rules before a prize will be awarded. Sponsor reserves the right, in its sole discretion, to disqualify any Entrant or entry it determines to be incomplete, fraudulent, tampered with, or otherwise non-compliant with these Official Rules. All entries become the property of Sponsor and will not be acknowledged or returned.

Limitations

Limit one (1) entry per person during the Entry Period regardless of entry method. Limit one (1) prize per person for the Entry Period. Entries will not carry forward to a drawing for any future entry period.

Disqualification

Each Entrant represents and warrants that his or her entry conforms to these Official Rules and understands that Sponsor, in its sole discretion, may disqualify the entry for any reason, including if it determines, in its sole discretion, that the entry fails to conform to these Official Rules in

any way. Sponsor in no way promotes illegal acts, and any and all entries which include or promote illegal acts will be disqualified. Entries generated by script, macro, bot, or any other automated means, or by any means which subvert the entry process, are void. Any attempt by any Entrant to obtain more than the allowed number of entries per person by using multiple or different email addresses, identities, registrations, logins, or any other methods will void any entry by that Entrant and could result in disqualification from this Sweepstakes and/or disqualification from all future sweepstakes by the Sponsor, at Sponsor's sole discretion.

Prize Drawing and Odds of Winning

There will be one (1) winner (the "**Winner**") of the Sweepstakes for the Entry Period. The decisions of Sponsor, including the selection of the Winner, are final and binding on all matters relating to this Sweepstakes. Odds of winning depend on the total number of eligible entries received during the Entry Period. The Winner will be determined by random drawing on or before October 15, 2026.

Prize

The Winner will receive a Sing for Churches subscription on www.sing.theworshipinitiative.com for a duration of three (3) months (valued at \$297) (the "**Prize**"). The Winner is solely and fully responsible for any and all applicable federal, state, city, and local taxes (including income and withholding taxes) on the value of the Prize, and, if applicable, will be issued an IRS Form 1099-MISC for the retail value of the Prize.

The Prize is awarded "AS IS." Neither Sponsor nor any of its affiliates makes or offers any warranty or guarantee, either express or implied (including, without limitation, quality, merchantability, and fitness for a particular purpose), in connection with this Sweepstakes or the Prize. Winner Notification and Verification

The Winner will be notified by email or phone by the Sponsor on or before October 15, 2026. Awarding of the Prize is subject to verification of the potential Winner's eligibility and full compliance with these Official Rules, in the sole discretion of the Sponsor. To claim the Prize, Sponsor may require the Winner to complete, sign, and return an Affidavit of Eligibility, Liability Release, and Publicity Release, and other applicable documents if necessary, which may require a social security number, postmarked within five (5) days of the date on the notification. At Sponsor's discretion, the Winner may be required to produce photo ID or other proper identification to claim the Prize.

If a potential Winner cannot be contacted, is disqualified, fails to timely execute and return any required forms, or if the Prize notification is returned as undeliverable, an alternate Winner will be selected by random drawing from all remaining eligible entries. If by reason of printing or other error more prizes are claimed than the number of prizes set forth in these Official Rules, a random drawing will be held to award the advertised number of prizes in the relevant category. Under no circumstances will more than the advertised number of prizes be awarded.

Agreement to Official Rules

Disputes

Entrants and the Winner agree that any and all disputes and causes of action arising out of or connected with this Sweepstakes and the Prize awarded shall be resolved solely by Sponsor, shall be final and binding, and shall be resolved without resort to any form of class action.

General Conditions
